








## **JOURNAL AD & LOGO GUIDELINES**

#### **AD ARTWORK**

Ad artwork should be in black/white/grayscale and high resolution at the measurements noted above. Full color artwork will be converted to black/white/grayscale.

Ads should be in one of the following file formats:

PDF (high quality / fonts embedded)

JPG (high resolution / 300 dpi)
